RANCHO VENTANA RV PARK BOARD OF DIRECTORS MEETING DECEMBER 9, 2008

MINUTES

PRESENT: S. Casorso, R. Gordon, S. Hunley, W. Orriss, K. Zidar (recorder)

1.0 CALL TO ORDER

W. Orriss welcomed everyone, called the meeting to order at 2:30 p.m., and introduced the above noted.

2.0 OPEN FORUM

Lot 123 – E. Cornwell. Asked if there were electrical problems in the Park. Was advised that the outages were city outages and not related specifically to the Park.

Lot 179 - B. Coates. Requested that instructions be put in writing for opening and closing the pool cover and that they be available with the key. Good idea.

3.0 APPROVAL OF THE NOVEMBER 12, 2008 MINUTES

MOTION 08/12/01 MOVED BY: S. Casorso SECONDED BY: R. Gordon THAT the minutes of the November 12, 2008 Board of Directors meeting be approved as presented. CARRIED.

4.0 COMMITTEE REPORTS

4.1 ARCHITECTURAL

T. Swarts presented the report attached as Appendix A. In addition to that he noted the he and W. Orriss checked 20+ completion forms for work that has been done.

4.2 MAINTENANCE

R. Gordon is taking over temporarily during R. Fuller's absence. There are 10 projects on the go. There are a lot of crews working around the Park on the pool, trees, etc. These people are volunteers and it would be nice for members to say "thanks" to them for taking the time to help with these projects. The Committee is also looking into getting street lights for some of the darker areas in the Park. They're working with the City and

Edison in the hopes of getting about 7 new street lights. They are also looking for a member with auto repair experience to help fix up the old golf cart and some other items. R. Gordon thanked all the fellows working on the Maintenance crew for their help and the work that they've done.

4.3 SOCIAL

Barbara McAvoy presented the report. A breakfast was held November 2nd; Steak Night on November 21st; Thanksgiving Dinner on November 27th. The Committee has a new member – Denis Nagy. A Pool Tournament was held. Collection for the Christmas Fund has started with a successful silent auction and golf ball sale (thanks to Sonny for the golf balls). Members were urged to support the fund – additional funds are needed. The first t-shirt sale was held.

Upcoming December events include a Soup Night on December 13th. Rick Morgenstern will be performing. There will be a Kids Choir coupled with a Wine, Cheese and Desserts Night on December 18th. A Horseshoe Tournament will be held December 19th, Christmas Dinner on December 25th. Regular bi-weekly bingos will continue to be held. Members were urged to keep checking the Social Committee News Board about regular clubhouse events. The first news/events letter was sent to each member this month.

4.4 FINANCE

M. Myers was not present but W. Orriss reported that everything is going well and that M. Myers is doing a great job. A package is going out to homeowners including the budget for next year. Of interest is the fact that Maintenance Fees are not increasing.

4.5 COMMUNICATIONS

M.A. Gordon presented the report attached as Appendix B.

R. Gordon presented the report. 5.1 NPG WIFI INTEREST

R. Gordon advised that a list has been posted in the Library and that 67 people had indicated an interest for WIFI. NPG has indicated that they need 75 people signed up to save \$5.00 per month. The savings does not justify the work or time that has to be spent on this item at this time.

Edison does not want anything wireless on their posts so that is not an option at this time. R. Gordon is still searching for a solution.

The letter is attached as Appendix C. The Board agrees that this is a good idea and the box will be moved to the Office Area.

6.2 REQUEST FROM MESA VILLA TO SHARE BEAUTIFICATION EXPENSE

A copy of a bill received from R. Taylor for the cost of rock for the empty area between Mesa Villa and Rancho Ventana was presented to the Board with a request to share the expense, which was approximately \$325.00 total. The work was done by two of our members using Mesa Village equipment and it was agreed that it looks much better than the bare dirt. The Board agreed to share the cost (\$162.50).

6.3 ANY INCOMING CORRESPONDENCE RECEIVED PRIOR TO THE MEETING

7.0 NEW BUSINESS

7.1 ANA AVALOS' RESIGNATION AND REPLACEMENT PROCESS

A copy of A. Avalos' letter of resignation is attached as Appendix D (effective July 31, 2009). The Board has accepted the letter with regret and wished Ana all the best. The Board is putting together a list of requirements, a job description, etc., noting that finding a replacement would not be an easy process. The Board will keep membership apprised of the replacement process.

7.2 INVESTIGATING THE COST AND BENEFITS OF A SOLAR POWER SYSTEM

R. Gordon gave an update. Sun Power wants to look at the building and offer a price. The Board is looking into what has to be done to pursue this matter which would affect the swimming pool, electricity and hot water. The Board will continue to keep members informed of the progress being made on this matter. As an aside, Sun Power is willing to make a presentation before the Board proceeds with its search, and members who may be interested in individual solar power options should attend this presentation.

7.3 GATE CLOSURE OR OTHER REMEDIES FOR GATE SAFETY VIOLATIONS

R. Gordon noted that there is still a problem with the entrance gate being used as an exit. This is a definite liability problem.

MOTION 08/12/02 MOVED BY: R. Gordon SECONDED BY: S. Casorso THAT the Board agrees to have the entrance and exit gates closed fulltime for a trial period beginning January 1, 2009 until April 30, 2009. CARRIED.

Fifty gate openers have been ordered and will be rented out for \$35.00 refundable upon return. The entrance can be accessed with the gate code anytime as well. The Board will review the situation after the trial period.

7.4 PRE-AGM INFORMATION PACKET SENT OUT DECEMBER 5TH, 2008

Members with internet access were advised that this information will be available within the next day or two and were asked to review it. A package will be sent out in the mail to members with no internet access.

7.5 REMINDER REGARDING SELF-NOMINATION PROCESS FOR ELECTION

Information regarding the self-nomination process is included in the Pre-AGM package being sent out. The return date for self-nominations is January 9, 2009 at 2:00 p.m.

7.6 CANDIDATES FORUM

A Candidates Forum is scheduled for 2:00 p.m. on January 13th, 2009 at the Clubhouse. This will be a "town hall" meeting with an opportunity to ask questions of the candidates. Ballots for the election of the vacancies on the Board will be sent out on January 16th, 2009 and results will be announced at the AGM on Tuesday, February 17th, 2009.

7.7 INVESTIGATING THE POSSIBILITY OF INSTALLING A NINE HOLE PUTTING GREEN

The Social Committee is toying with the possibility of having a 1,500 sq. ft. putting green on the north side of the green space. Anyone interested with the pursuit of this project is asked to sign the list in the Library.

The next meeting will be held on Tuesday, January 13, 2009 at 2:30 p.m.

The meeting adjourned at 3:30 p.m.


