Work completed since the last Board Meeting includes: repairing the outside door on the west side of the Clubhouse, building cabinet for the R/O water system, cleaning up the attic area above the kitchen, tiling the floor where the stage was moved, and temporarily installing the solar street light on the maintenance shed. As well, broken

fencing was repaired and a window was replaced in the Clubhouse. There was also work on a new pool cover; it was not closing properly and a new one has been ordered at a cost of \$6,500.

Repairs need to be made around the pool and the shaded areas in the near future. Research is still being done on what will work best and last a few years. It is estimated that nothing will be done this year.
