# 3.1 ARCHITECTURAL

# 7.1 AL WILSON MEETING

The Board had the meeting with A. Wilson to discuss financials and the minutes of that meeting are available in the Office and on-line on our website.

#### 8.0 OPEN FORUM

Lot 120 - M. Zerr. Commented on the speed bumps and the danger that they present for people on bicycles. Some sort of spacing is required for the bikes to go through.

Lot 154 - A. Wilson. Thanked the Board for the meeting. He stated that in a previous meeting the 2013 financials had just been received and asked why it took so long. He also asked if a balance sheet would be provided at the AGM.

M. Myers stated that the 2014 financials will not be provided at the AGM because they have not been audited. The reason the 2013 financials took so long were because of a dispute between accountants.

Lot 195 - J. Forbes. Asked about the status of the street numbering. B. Macgregor responded that the Board realized that their proposal meant that the numbers would be on private property and the numbers cannot be put on without the owners' approval so the Board will be reviewing the matter again.

Lot 26-S. Kashuba. Asked how the speed bumps came about. W. Orriss explained the ongoing problem of speediness on the streets and about the repeated warnings to slow down, to no avail. The Board does not want speed bumps but have brought the portable speed bump in to make people realize the problems of having them. Final word – slow down. Mr. Kashuba also stated that the speed bumps were hazardous for bicyclers. The Board will address that issue.

Lot 20 - B. Weeks. Not totally adverse to speed bumps. Bicycles can use the space between the bump and the curb.

Lot 120 - M. Zerr. Asked the Board to come up with a safe option for bicycles.

Lot 86 - D. Honeyborn. Stated that this is just a test speed bump, which he thinks is a good thing to get people to slow down.

Lot 178 – B. Beblow. Stated no one wants speed bumps but at least having this trial is getting people talking about and thinking about going slower.

Lot 154 – A. Wilson. Stated that there are speed bumps in the resort he lives in in Canada and there is a 4 foot gap in the center which provides enough room for a golf cart of bicycle to go through.
