3.0 COMMITTEE REPORTS

3.1 ARCHITECTURAL

Sandra Vanderbrink advised the committee is working on simplifying/updating the paperwork required for permits. It has been provided to the Board for review. Not a lot going on regarding Architectural other than lots of painting. Blair Macgregor added that it appears to be a simpler process for permits.

3.2 MAINTENANCE

Blair Macgregor advised the park will be having a water outage for approximately two hours while they repair the back flow valve, near the golf course exit gate. A rebuilt valve will be installed. The time will be posted a few days in advance and should be either next Wednesday the 17th or Wednesday the 24th.

3.3 SOCIAL

Jacqui Clearwater read the Social Committee Report, attached as Appendix "A", and thanked all the volunteers. Thank you to Kent Walker for building the two sets of corn hole games. The social club is requesting that bleach not be used for cleaning the table cloths any longer. There are three jugs of pre-made solution consisting of peroxide, dish soap, alcohol, etc to be used. Bonnie Edgar will monitor when new solution will be needed to be made up.

3.4 FINANCE

Ursla Da Rugna indicated the year end is currently being worked on.

There is one lot that is two years in arrears. Started procedures to put a lien on the lot. There has been no response from the owner.

With the changeover from Union Bank to US Bank, a new business savings account has been setup. The interest rate is 4.5% which is better than previous.

3.5 RECYCLING

Wayne Lawson indicated there were four trips made in January for recycling. People are learning how to sort and recycle. Disbursement are \$134.00 for new trash/recycle units. Thank you to Eli for finding them. \$135.00 paid for gas for Eli to pick up the containers. \$500.00 has been donated from the Recycling Committee towards the purchase of defibrillators.

4.0 PARK MANAGER'S REPORT

Yasika read the Park Manager's Report. See report attached as Appendix "B".

6.0 UNFINISHED BUSINESS

6.1 Pool Cover.

Blair Macgregor indicated the pool cover got ripped and the pool was not covered for the month of December. Most of the repair cost was under warranty. The bill for repair was under \$400.00 and felt this was pretty good as the company came from the coast to do the repairs. As we had a mild December it cost \$4,500. to heat the pool, compared to last December at approximately \$8,000. The pool cover will be open on the pool from 9 am to 4 pm daily.

7.0 NEW BUSINESS

7.1 Staffing.

Blair Macgregor read notes regarding staffing which are attached as Appendix "C". As Junior has now been hired, when you see him welcome him on board. Also a big round of applause was offered to thank Eli for his help.

8.0 OPEN FORUM FOR HOMEOWNERS

Bob Ingersoll, Lot 34, asked if the motor was OK on the pool cover. Blair Macgregor indicated yes the motor is OK. The company who repaired the cover brought new fabric and hand stitched it into place.

The next Board of Directors' Meeting is scheduled for Tuesday, February 13, 2024 at 3:00 pm, followed immediately by the Annual General Meeting.

We have completed the following and have spent approx. \$930.00 (see below)



Good afternoon everyone.

Thank you all for the wonderful gifts and all the cards we are truly blessed to have a wonderful community who cares.

Pets, keep your pets off of the common areas of the park, which includes the grass, club house, pool area, and all common rock areas. Do not walk your pet on the golf course.

If you are driving at night please use your lights in the park whether you are in a car or golf cart or bike, please slow down. If you have no lights on your golf cart use a flash light.

If you use the club house for any type of event you are to leave it as you found it. That means you put away all your tables, chairs and pick up trash and empty out the trash cans and sweep and pick it up, a broom and dust pan are provided in the table and chair area. Same goes for the pool area, if you turn chairs around or move them they go back as you found them. Pick up your trash and put your recycling in the proper bins. All tables and chairs that are in the clubhouse must stay in the clubhouse and all patio furniture must stay out of the clubhouse area.
